Pursuant to Section 412 of the District of Columbia
Self-Government and Governmental Reorganization Act (PL 93-198),
the Act, the Council of the District of Columbia adopted Bill
No. 1-329 on first and second readings September 15, 1976, and
October 12, 1976, respectively. Following the signature of the
Mayor on November 8, 1976, this legislation was assigned Act
No. 1-171, published in the November 26, 1976, edition of the
D.C. Register, and transmitted to both Houses of Congress for
a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired and, therefore, cites the following legislation as D. C. Law 1-102, effective April 6, 1977.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

April 6, 1977

To permit patrons of restaurants and hotels to be served alcoholic beverages while standing up.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Standing Up Service Act".

- Sec. 2. (a) The fourth, fifth, and sixth sentences of section 11(g) of the District of Columbia Alcoholic Beverage Control Act (D.C. Code, sec. 25-111(g)) are repealed.
- (b) The fourth, fifth, and sixth sentences of section 11(h) of the District of Columbia Alcoholic Beverage Control Act (D.C. Code, sec. 25-111(h)) are repealed.
- (c) Section 4.5 of the Alcoholic Beverage Control Regulations (3 DCRR 4.5) is repealed.

Sec. 3. This act shall take effect immediately following the period provided for Congressional review in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act.
