"The District of Columbia Fire Department Operations Act of 1976".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, (PL 93-198) the Act, the Council of the District of Columbia adopted Bill No. 1-377 on first and second readings July 27, 1976 and September 15, 1976, respectively. Following expiration of the ten-day period provided the Mayor, in which no action was taken, pursuant to Section 404 (e) of the Act, this legislation was assigned Act No. 1-198 and transmitted to both Houses of Congress for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The full text of Act No. 1-198 is herewith published.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional review period has expired and, therefore, cites the following legislation as D. C. Law 1/11, effective April 7, 1977.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

April 7, 1977

To establish Fire Department Companies and require Council approval of any major change in such companies or the provision or location of station houses.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as "The District of Columbia Fire
Department Operations Act of 1976."

Sec. 2. The Act of June 20, 1906, 34 Stat. 315, Chapter 3443, section I, D.C. Code, Section 4-401, is mended to read as follows:

"The Fire Department of the District of Columbia shall provide fire prevention and fire protection within the geographical boundaries of the District of Columbia. The District shall be divided into such fire companies, and other units as the Council of the District of Columbia may from time to time direct. Major changes in the manner the Department provides fire protection and fire prevention shall be approved by resolution of the Council."

Sec. 3. This act shall become effective according to the provisions of Section 602 (c) of the District of Mumbia Self-Government and Governmental Reorganization Act.
