


COUNCIL OF THE DISTRICT OF COLUMBIA

NOTICE

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act (PL 93-198)(the Act), the Council of the District of Columbia adopted Bill No. 1-9 on first and second readings February 18, 1975 and March 4, 1975, respectively. Following the signature of the Mayor on March 13, 1975, this legislation was assigned Act No. 1-3 and transmitted to both Houses of Congress for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional review period has expired and, therefore, cites the following legislation as D.C. Law No. 1-2, effective May 13, 1975.

To amend the District of Columbia Unemployment Compensation Act

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,

that the District of Columbia Unemployment Compensation Act, approved August 28, 1935, as amended, is further amended as follows:

(1) Section 3 of such Act (D.C. Code, sec. 46-303) is amended by adding at the end thereof the following new subsection:

"(j) Notwithstanding any of the provisions of this Act, no employer's experience rating account shall be charged and no employer shall be liable for payments in lieu of contributions with respect to extended benefit payments which are wholly reimbursed to the District of Columbia by the Federal Government."

(2) Subsection (5) of section 7 of such Act (D.C. Code, sec. 46-307(g)) is amended by adding at the end thereof the following new paragraph:

unemployment beginning before December 31, 1976, and beginning after December 31, 1974, the determination of whether there has been:

"(1) a State 'on' or 'off' indicator for the District beginning or ending any extended benefit period shall be made under this subsection as if this subsection did not contain paragraphs (1)(D)(i) and (1)(E)(i) thereof, and

"(2) a national 'on' or 'off' indicator beginning or ending any extended benefit period shall be made under the provisions of this subsection as if the phrase '4.5 percentum; contained in paragraphs (1)(B) and (1)(C) thereof read '4.0 percentum.'"

Section 2.2 The amendments made by this act shall take effect immediately upon passage of this act.
