


COUNCIL OF THE DISTRICT OF COLUMBIA

NOTICE

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act ( PL 93-198 ) the Act, the Council of the District of Columbia adopted Bill No. 1-211 on first and second readings February 24, 1976, and March 9, 1976, respectively. Following the signature of the Mayor on March 29, 1976, this legislation was assigned Act No. 1-102, published in the April 12, 1976, edition of the D.C. Register, and transmitted to both Houses of Congress for a 30-day review, in accordance with Section 602(c) (1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional review period has expired and, therefore, cites the following legislation as D.C. Law No. 1-69, effective June 15, 1976.

D.C. LAW 1-69

In the Council of the District of Columbia

June 15, 1976

To extend the authorization of appropriation for the provision of legal defense to indigent persons in the District of Columbia.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,  
That this act may be cited as the "Criminal Justice Act  
Authorization Extension act".

Sec. 2. Section 11-2608 of the Act of September 3, 1974, 88 Stat. 1089 (D.C. Code, sec. 11-2608) is amended by striking therefrom the words "for fiscal years 1975 and 1976".

Sec. 3. This act shall take effect at the end of the thirty day period provided for Congressional review of acts of the Council in section 602(c) of the District of Columbia Self-Government and Governmental Reorganization Act.
