"Fuels Technology Temporary Amendment Act of 1994".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 10-591 on first and second readings, March 1, 1994, and April 12, 1994, respectively. Following the signature of the Mayor on April 28 1994, this legislation was assigned Act No. 10-231, and published in the May 13, 1994, edition of the <u>D.C. Register</u> (Vol.41 page 2590) and transmitted to Congress on May 5, 1994 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 10-132, effective June 28, 1994.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

APRIL 28, 1994

To amend, on a temporary basis, the Alternative Fuels Technology Act of 1990 to delete certain provisions dependent upon the issuance of rules.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Fuels Technology Temporary Amendment Act of 1994".

Sec. 2. Section 4 of the Fuels Technology Act of 1990, effective March 8, 1991 (D.C. Law 8-293; D.C. Code § 40-2003), is amended as follows:

Nôte, Section 40-2003

- (a) Subsection (a) is repealed.
- (b) Subsection (c) is amended by striking the phrase ", pursuant to rules issued by the Mayor.".
- Sec. 3. (a) This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.

(b) This act shall expire on the 225th day of its having taken effect.
