"South Africa Sanctions Repeal Act of 1994".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 10-427 on first and second readings, March 1, 1994, and April 12, 1994, respectively. Following the signature of the Mayor on April 28 1994, this legislation was assigned Act No. 10-234, and published in the May 13, 1994, edition of the <u>D.C. Register</u> (Vol.41 page 2597) and transmitted to Congress on May 5, 1994 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 10-134, effective June 28, 1994.
