D.C. LAW 10-149

"Hacker's License Requirements Amendment Act of 1984 Temporary Amendment Act of 1994".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 10-646 on first and second readings, May 3, 1994, and June 7, 1994, respectively. Following the signature of the Mayor on June 23, 1994, this legislation was assigned Act No. 10-262, and published in the July 8, 1994, edition of the <u>D.C. Register</u> (Vol.41 page 4485) and transmitted to Congress on June 27, 1994 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 10-149 effective August 17, 1994.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JUNE 23, 1994

To amend, on a temporary basis, An Act Making appropriations to provide for the expenses of the government of the District of Columbia for the fiscal year ending June thirtieth, nineteen hundred and three, and for other purposes, to increase the hacker's license training course from a 12- to a 24-hour course, to increase the fee from \$25 to a fee of not less than \$100 per person, and to direct the University of the District of Columbia to resume teaching this course by July 1, 1994.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Hacker's License Requirements Amendment Act of 1984 Temporary Amendment Act of 1994".

Sec. 2. Paragraph 11 of section 7 of An Act Making appropriations to provide for the expenses of the government of the District of Columbia for the fiscal year ending June thirtieth, nineteen hundred and three, and for other purposes, approved July 1, 1902 (32 Stat. 626; D.C. Code 47-2829(e)(2)(A)), is amended as follows:

Section 47 - 2829

(a) By striking the first 3 sentences and inserting the following: "Completion of the hacker's license training course consisting of not less than 24-hours administered by any person authorized by the District of Columbia Taxicab Commission for a fee of not less than \$100 for each applicant. Upon completion of the course, a certificate of completion shall be issued to include the date of completion and shall be presented to the Office of Taxicabs with the application for a license. Prior to issuing the certificate, each applicant shall pass a test consisting of the subject matters taught in the course and in evaluation of the applicant's English communication skills. The certificate of completion shall be issued only when an applicant has attended every session of the 24-hour course.".

Sec. 3. The University of the District of Columbia shall resume teaching the hacker's license training course by July 1, 1994.

Sec. 4. (a) This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)),

and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.

(b) This act shall expire on the 225th day of its having taken effect or upon the effective date of the District of Columbia Taxicab Commission Establishment Act of 1985 Amendment Act of 1994, whichever occurs first.
