IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

FEBRUARY 24, 1993

To amend on an emergency basis, the Rental Housing Act of 1985 to prevent housing providers from evicting tenants when the temperature is predicted to be below freezing within the next 24 hours.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Rental Housing Act of 1985 Frigid Temperature Emergency Amendment Act of 1993".

- Sec. 2. Section 501 of the Rental Housing Act of 1985, effective Note, Section July 17, 1985 (D.C. Law 6-10; D.C. Code § 45-2551), is amended as follows:
 - (a) Subsection (k) is amended as follows:
- (1) By striking the phrase "not exceed 25" and inserting the phrase "fall below 32" in its place;
- (2) By inserting the phrase "or 0 degrees centigrade" before the phrase "within the next 24 hours"; and
- (3) By adding a new sentence at the end to read as follows: "This subsection shall also apply to housing owned by the District government.".
 - (b) A new subsection (k-1) is added to read as follows:
- "(k-1) Notwithstanding any provisions of this section, a housing provider can evict a tenant where the tenant's action or presence causes undue hardship on the health, welfare, and safety of others.".
- Sec. 3. This act shall take effect upon its enactment (approval by the Mayor, or in the event of veto by the Mayor, override of the veto by the Council) and shall remain in effect for no longer than 90 days, as provided for emergency acts of the Council of the District of Columbia in section 412(a) of the District of Columbia Self-Government and
