"Retired Police Officer Redeployment Salary Limit Amendment Act of 1994".

L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 10-471 on first and second readings, June 21, 1994 and July 5, 1994, respectively. Following the signature of the Mayor on July 25, 1994, this legislation was assigned Act No. 10-290, and published in the August 5, 1994, edition of the <u>D.C. Register</u> (Vol.41 page 5147) and transmitted to Congress on July 28, 1994 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 10-170 effective September 22, 1994.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JULY 25, 1994

To amend the Retired Police Officer Redeployment Amendment Act of 1992 to raise the limit on the amount of salary a rehired annuitant may be paid.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Retired Police Officer Redeployment Salary Limit Amendment Act of 1994".

Sec. 2. Section 2(d) of the Retired Police Officer Redeployment Amendment Act of 1992, effective September 29, 1992 (D.C. Law 9-163; to be codified at D.C. Code § 4-618.1), is amended by striking the phrase "Class 1, Step 1 Officer" and inserting the phrase "Class 1, Step 5 Officer" in its place. Section 4-618.1

Sec. 3. Effective date.

This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
