D.C. LAW 10-172

"Comprehensive Merit Personnel Reemployed Annuitant  
Amendment Act of 1994".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 10-571 on first and second readings, June 21, 1994 and July 5, 1994, respectively. Following the signature of the Mayor on July 25, 1994, this legislation was assigned Act No. 10-292, and published in the August 5, 1994, edition of the D.C. Register (Vol.41 page 5152) and transmitted to Congress on July 28, 1994 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 10-172 effective September 22, 1994.

AN ACT

D.C. ACT 10-292

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JULY 25, 1994

To amend the District of Columbia Government Comprehensive Merit Personnel Act of 1978 so that federal and military retirees selected for employment in the District Government for service will not be subject to the reduction of pay allocable to the period of employment as a reemployed annuitant.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Comprehensive Merit Personnel Reemployed Annuitant Amendment Act of 1994".

Sec. 2. Section 1103(b) and (c) of the District of Columbia Government Comprehensive Merit Personnel Act of 1978, effective March 3, 1979 (D.C. Law 2-139; D.C. Code § 1-612.3(b) and (c)), is amended as follows:


Sec. 3. This act shall apply prospectively to eligible employees beginning on the 1st pay period after the effective date of the Comprehensive Merit Personnel Reemployed Annuitant Amendment Act of 1994.

Sec. 4. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code §1-233(c)(1)), and

publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.

AN ACT

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To amend the District of Columbia Government Comprehensive Merit Personnel Act of 1978 so that federal and military retirees selected for employment in the District Government for service will not be subject to the reduction of pay allocable to the period of employment as a reemployed annuitant.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Comprehensive Merit Personnel Reemployed Annuitant Amendment Act of 1994".

Sec. 2. Section 1103(b) and (c) of the District of Columbia Government Comprehensive Merit Personnel Act of 1978, effective March 3, 1979 (D.C. Law 2-139; D.C. Code § 1-612.3(b) and (c)), is amended as follows:


