**District of Columbia** Code (1995 Supplement)

#### IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To amend An Act To increase compensation for District of Columbia policemen, firemen, and teachers; to increase annuities payable to retired teachers in the District of Columbia; to establish an equitable tax on real property in the District of Columbia; to provide for additional revenue for the District of Columbia; and for other purposes to add additional alternate members to the Police and Firemen's Retirement Relief Board.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Policemen and Firemen's Retirement Relief Board Amendment Act of 1994".

Sec. 2. Section 122(a) of An Act To increase compensation for District of Columbia policemen, firemen, and teachers; to increase annuities payable to retired teachers in the District of Columbia; to establish an equitable tax on real property in the District of Columbia; to provide for additional revenue for the District of Columbia; and for other purposes, approved September 3, 1974 (88 Stat. 1041; D.C. Code § 4-628(a)) is amended as follows:

(a) Paragraph (1) is amended to read as follows:

"(1) Members and alternatives appointed from among persons who are employees of the District of Columbia, 1 member and 1 or more alternates from each of the following: the District of Columbia Office of Personnel, Corporation Counsel, Department of Human Services, the Metropolitan Police Force, and the Fire and Emergency Medical Services Department; and".

(b) The undesignated sentence following paragraph (2) is amended as follows:

(1) By striking the word "alternate" and inserting the phrase "1 or more alternates" in its place; and

(2) By striking the word "both".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in either the District of Columbia Register, the District Section 4-628 of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 10-174 effective September 22, 1994.

#### JULY 25, 1994

To amend An Act To increase compensation for District of Columbia policemen, firemen, and teachers; to increase annuities payable to retired teachers in the District of Columbia; to establish an equitable tax on real property in the District of Columbia; to provide for additional revenue for the District of Columbia; and for other purposes to add additional alternate members to the Police and Firemen's Retirement Relief Board.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Policemen and Firemen's Retirement Relief Board Amendment Act of 1994".

Sec. 2. Section 122(a) of An Act To increase compensation for District of Columbia policemen, firemen, and teachers; to increase annuities payable to retired teachers in the District of Columbia; to establish an equitable tax on real property in the District of Columbia; to provide for additional revenue for the District of Columbia; and for other purposes, approved September 3, 1974 (88 Stat. 1041; D.C. (1) By striking the word "alternate" and inserting the phrase "1 or more alternates" in its place; and

(2) By striking the word "both".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in either the District of Columbia Register, the District Section 4-628 of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
