### D.C. LAW 10-214

"District of Columbia Retirement Board Judicial Appointment Amendment Act of 1994".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 10-613 on first and second readings, November 1, 1994 and December 6, 1994, respectively. Following the signature of the Mayor on December 15, 1994, this legislation was assigned Act No. 10-351, and published in the December 23, 1994, edition of the D.C. Register (Vol. 41 page 8034) and transmitted to Congress on January 31, 1995, for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 10-214, effective March 16, 1995.

### IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

## DECEMBER 15, 1994

To amend the District of Columbia Retirement Reform Act to provide for alternate representation for judges on the District of Columbia Retirement Board.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Retirement Board Judicial Appointment Amendment Act of 1994".

Sec. 2. Section 121(b)(1)(A)(vii) of the District of Columbia Section Retirement Reform Act, approved November 17, 1979 (93 Stat. 870; D.C. 1-711 Code § 1-711(b)(1)(A)(vii)), is amended to read as follows:

"(vii) One senior judge and an alternate senior judge

appointed by the Joint Committee on Judicial Administration of the District of Columbia.".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)),
