"Lie Detector Tests for Pre-Employment Investigations Amendment Act of 1994".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 10-693 on first and second readings, November 1, 1994 and December 6, 1994, respectively. Following the signature of the Mayor on December 15, 1994, this legislation was assigned Act No. 10-352, and published in the December 23, 1994, edition of the D.C. Register (Vol. 41 page 8036) and transmitted to Congress on January 31, 1995, for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day

Congressional Review Period has expired, and therefore, cites this enactment as D.C.

D.C. ACT 10-352

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

DECEMBER 15, 1994

To amend the Prevention of the Administration of Lie Detection Procedures Act of 1978 to extend the use of polygraph tests to pre-employment investigations conducted by the Metropolitan Police Department, the Fire Department, and the Department of Corrections.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Lie Detector Tests for Pre-Employment Investigations Amendment Act of 1994".

Sec. 2. Section 2(b) of the Prevention of the Administration of Lie Detection Procedures Act of 1978, effective March 6, 1979 (D.C. Law 2-154; D.C. Code § 36-802(b)), is amended to read as follows:

Section 36-802

- "(b) The provisions of this section shall not apply to any criminal or internal disciplinary investigation, or pre-employment investigation conducted by the Metropolitan Police, the Fire Department, and the Department of Corrections; provided that any information received from a lie detector test which renders an applicant ineligible for employment shall be verified through other information and no person may be denied employment based solely on the results of a pre-employment lie detector test.".
- Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code §1-233(c)(1)), and
