# **D.C. LAW 10-221**

"District of Columbia Board of Education Fees for Select Adult, Community, and Continuing Education Courses Act of 1994".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 10-656 on first and second readings, November 1, 1994 and December 6, 1994, respectively. Following the signature of the Mayor on December 15, 1994, this legislation was assigned Act No. 10-358, and published in the December 23, 1994, edition of the D.C. Register (Vol. 41 page 8047) and transmitted to Congress on January 31, 1995, for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 10-221, effective March 16, 1995.

## IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

# DECEMBER 15, 1994

To authorize the District of Columbia Board of Education to charge fees for select adult, community, and continuing education courses.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Board of Education Fees for Select Adult, Community, and Continuing Education Courses Act of 1994".

Sec. 2. Definitions.

For purposes of this act, the phrase "Select Adult, Community, and Continuing Education Course" means an adult, community, and continuing education course which is either recreational or vocational in nature.

Sec. 3. Fees for select District of Columbia Board of Education adult, continuing, and community education courses.

New Section 31-132

- (a) The District of Columbia Board of Education ("Board of Education") is authorized to charge fees for select adult, community, and continuing education courses, provided that no fees shall be charged for Adult Basic Education, Adult Secondary Education Diploma Programs or General Education Development Programs, and Adult English as a Second Language Programs, Levels I through IV.
- (b) The amount which shall be charged with respect to each select adult, community, and continuing education course shall be fixed annually by the Board of Education as the amount necessary to cover the expense of instruction, cost of textbooks and school supplies, and other operating costs associated with each course offered: Provided, that such an amount and changes in the amount fixed by this subsection are set by the Board of Education in accordance with section 6 of the District of Columbia Administrative Procedure Act, approved October 21, 1968 (82 Stat. 1206; D.C. Code § 1-1506). Following the final adoption of such amounts, the Board of Education shall transmit a copy to the Mayor and a copy to the Council of the District of Columbia.
- (c) All amounts received by the Board of Education under this section shall be paid to the D.C. Treasurer and accounted for in the General Fund as a separate revenue source allocable to provide authority for the offering of select adult, community, and continuing education courses for which fees will be charged.
- (d) As part of its fiscal year 1995 Supplemental Budget, the Board of Education shall request that an amount equal to the fees collected and

deposited into the General Fund pursuant to this act, be appropriated to the Board of Education for the purpose of paying for instructors' salaries, textbooks and supplies, and other operating costs associated with offering select adult, community, and continuing education courses.

(e) Waivers, in whole or in part, of fees for select adult, community, and continuing education courses may be granted by the Board of Education only to District residents, regardless of an individual's or a student's employment status with the Board or the District of Columbia Public Schools.

Sec. 4. Accountability for funds received.

The District of Columbia Board of Education shall account for all funds received pursuant to this act.

Sec. 5. Rulemaking.

The Board of Education, pursuant to title 1 of the District of Columbia Administrative Procedure Act, approved October 21, 1968 (82 Stat. 1204; D.C. Code § 1-1501 et seq.), shall issue rules to implement the provisions of this act.

Sec. 6. Effective date.

This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
