IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

DECEMBER 15, 1994

To amend, on an temporary basis, An Act Making appropriations to provide for the expenses of the government of the District of Columbia for the fiscal year ending June thirtieth, nineteen hundred and three and for other purposes to authorize the imposition of a fee for special events; and to repeal the Law School Clinical Programs Funding Authorization Act of 1978.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Budget Spending Reduction Temporary Amendment Act of 1994".

Sec. 2. Special events.

(a) Paragraph 26 of section 7 of An Act Making appropriations to provide for the expenses of the government of the District of Columbia for the fiscal year ending June thirtieth, nineteen hundred and three and for other purposes, approved July 1, 1902 (47 Stat. 554; D.C. Code § 47-2826), is amended as follows:

(1) By designating the existing text as subsection (a); and

(2) By adding a new subsection (b) to read as follows:

"(b) The Mayor may adjust the license fee set in subsection (a) of this section to cover the costs to the District of providing police, fire, and other public services that are necessary to protect public health and safety.".

(b) The Mayor shall establish by rule a schedule of license fees for special events held on public space to cover the costs to the District of providing police, fire, and other public services that are necessary to protect public health and safety.

Sec. 3. Law school clinical program repeal.

The Law School Clinical Programs Funding Authorization Act of 1978, effective March 3, 1979 (D.C. Law 2-143; D.C. Code § 31-1901 et seq.), is repealed.

Sec. 4. (a) This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), Section 47-2826
