### D.C. LAW 10-225

"Councilmembers' Salary Freeze Amendment Act of 1994".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 10-696 on first and second readings, November 1, 1994 and December 6, 1994, respectively. The legislation was deemed approved without the signature of the Mayor on December 20, 1994, pursuant to Section 404(e) of "the Act", and was assigned Act No. 10-365, and published in the December 30, 1994, edition of the D.C. Register (Vol. 41 page 8122) and transmitted to Congress on January 31, 1995, for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 10-225, effective March 16, 1995.

### AN ACT

# D.C<u>. ACT</u> 10-365

### IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

# DECEMBER 21, 1994

To amend the District of Columbia Government Comprehensive Merit Personnel Act of 1978 to freeze the salaries of members of the Council and to request that Congress amend the District of Columbia Self-Government and Governmental Reorganization Act to disconnect the salaries of Council Chairman and other Councilmembers and to eliminate the prohibition on outside employment by the Chairman.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Councilmembers' Salary Freeze Amendment Act of 1994".

Sec. 2. Section 1109(b) of the District of Columbia Government Comprehensive Merit Personnel Act of 1978, effective March 3, 1979 (D.C. Law 2-139; D.C. Code § 1-612.9(b)), is amended as follows:

Section 1-612.9

- (a) By striking the phrase "shall be paid at an annual rate \$10,000 less than the annual compensation established for the Chairman" and insert the phrase "shall be paid at the rate authorized for the members on June 7, 1994 which shall be paid in equal and periodic installments" in its place; and
- (b) By striking the phrase "equivalent to the highest rate of basic pay authorized for an executive agency head" and inserting the phrase "equivalent to the rate or basic pay he received on June 7, 1994" in its place.
- Sec. 3. (a) Section 2(a) of this act shall apply upon amendment to section 403(c) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 787; D.C. Code § 1-226(c)), which strikes the phrase "The Chairman shall receive, in addition to the compensation to which he is entitled as a member of the Council, \$10,000 per annum, payable in equal installments, for each year he serves as Chairman".
- (b) Section 2(b) of this act shall apply upon amendment to section 403(c) to strike the phrase "but the Chairman shall not engage in any employment (whether as an employee or a self-employed individual) or hold any position (other than his position as Chairman), for which he is compensated in an amount in excess of his actual expenses in connection therewith".

- Sec. 4. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
- Sec. 5. The Council requests that the United States Congress enact legislation to repeal section 403(c) of the District of Columbia Self-Government and Governmental Reorganization act, approved December 24, 1973 (87 Stat. 787; D.C. Code § 1-226(c)).
