D.C. LAW 10-231

"Chiropractic Licensing Amendment Act of 1994".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 10-142 on first and second readings, November 1, 1994 and December 6, 1994, respectively. Following the signature of the Mayor on December 27, 1994, this legislation was assigned Act No. 10-373 and published in the January 6, 1995, edition of the D.C. Register (Vol. 42 page 15) and transmitted to Congress on Feburary 3, 1995 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 10-231, effective March 21, 1995.

AN ACT

D.C. ACT 10-373

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

DECEMBER 27, 1994

To amend the District of Columbia Health Occupations Revision Act of 1985 to provide for the licensing of doctors of chiropractic and the regulation of the practice of chiropractic.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Chiropractic Licensing Amendment Act of 1994".

- Sec. 2. The District of Columbia Health Occupations Revision Act of 1985, effective March 25, 1986 (D.C. Law 6-99; D.C. Code § 2-3301.1 et seq.), is amended as follows:
- (a) Section 101(1) (D.C. Code § 2-3301.1(1)) is amended by inserting the phrase "the Board of Chiropractic," after the phrase "'Board' means".

(b) Section 102(3)(A) (D.C. Code § 2-3301.2(3)(A)) is amended to read as follows:

"(3)(A) "Practice of chiropractic" means the detecting and correcting of subluxations that cause vertebral, neuromuscular, or skeletal disorder, by adjustment of the spine or manipulation of bodily articulations for the restoration and maintenance of health; the use of x-rays, physical examination, and examination by noninvasive instrumentation for the detection of subluxations; and the referral of a patient for diagnostic x-rays, tests, and clinical laboratory procedures in order to determine a regimen of chiropractic care or to form a basis of referral of patients to other licensed health care professionals. The practice of chiropractic does not include the use of drugs, surgery, or injections, but may include, upon certification by the Board, counseling about hygienic and other noninvasive ancillary procedures authorized by rules issued pursuant to this act.".

(c) Section 203 (D.C. Code § 2-3302.3) is amended as follows:

(1) The section heading is amended by striking the phrase "Chiropractic,".

(2) Subsection (a)(2) is amended by striking the phrase "the practice of chiropractic with the advice of the Advisory Committee on Chiropractic.".

(3) Subsection (a)(8)(A) is amended inserting the word "and" after the semicolon.

- (4) Subsection (a)(8)(B) is repealed.
- (5) Subsection (c) is repealed.

- (6) Subsection (e) is amended by striking the phrase "Chiropractic," in the first sentence and striking the entire second sentence.
 - (7) Subsection (f) is amended by striking the first sentence.
- (d) Title 2 (D.C. Code §§ 2-3302.1 through 2-3302.13) is amended by adding a new section 214 to read as follows:

"Sec. 214. Board of Chiropractic.

"(a) There is established a Board of Chiropractic to consist of 5 members appointed by the Mayor with the advice and consent of the Council.

New Section 2-3302.14

- "(b) The Board shall regulate the practice of chiropractic.
- "(c) Of the members of the Board, 3 shall be doctors of chiropractic licensed to practice in the District, 1 shall be the Commissioner of Public Health or his or her designee, and 1 shall be a consumer member.

"(d) Except as provided in subsection (e) of this section, members

of the Board shall be appointed for terms of 3 years.

"(e) The members of the Advisory Committee on Chiropractic abolished by the Chiropractic Licensing Amendment Act of 1994 shall continue to serve as members of the Board of Chiropractic established by the Chiropractic Licensing Amendment Act of 1994 until the expiration of their terms on the Advisory Committee or until successors are appointed, whichever occurs later, and may be reappointed.".

(e) Section 504(b) (D.C. Code § 2-3305.4(b)) is amended as follows:

Section 2-3305.4

- (1) The lead-in language is amended by striking the phrase "Board of Medicine" and inserting the phrase "Board of Chiropractic" in its place.
 - (2) Paragraph (2) is amended to read as follows:
 "(2) Has satisfied any clinical experience established by rule.".
 - Sec. 3. Effective date.

This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and
