"Jury Trial Act of 1994".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 10-603 on first and second readings, November 1, 1994 and December 6, 1994, respectively. Following the signature of the Mayor on December 27, 1994, this legislation was assigned Act No. 10-374, and published in the January 6, 1995, edition of the D.C. Register (Vol. 42 page 15) and transmitted to Congress on Feburary 3, 1995 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 10-232, effective March 21, 1995.

D.C. ACT 10-374

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

DECEMBER 27, 1994

To amend section 16-705(c) of the District of Columbia Code to permit a judge of the Superior Court of the District of Columbia to take a verdict from 11 jurors in a criminal case where the court finds it necessary to excuse a juror for just cause after the jury has retired to consider its verdict.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Jury Trial Act of 1994".

Sec. 2. Section 16-705(c) of the District of Columbia Code is amended by adding a new sentence at the end to read as follows:

"Even absent such agreement, if, due to extraordinary circumstances, the court finds it necessary to excuse a juror for just cause after the jury has retired to consider its verdict, in the discretion

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)),
