Governmental Reorganization Act, P.L. 93-198 "the Act", the Council of the District of
Columbia adopted Bill No. 10-763 on first and second readings, November 1, 1994 and
December 6, 1994, respectively. Following the signature of the Mayor on December
27, 1994, this legislation was assigned Act No. 10-377, and published in the January 6,
1995, edition of the D.C. Register (Vol. 42 page 28) and transmitted to Congress on
Feburary 3, 1995 for a 30-day review, in accordance with Section 602(c)(1) of the Act.
The Council of the District of Columbia hereby gives notice that the 30-day
Congressional Review Period has expired, and therefore, cites this enactment as D.C.

#### IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

#### DECEMBER 27, 1994

To amend An Act Making appropriations to provide for the expenses of the government of the District of Columbia for the fiscal year ending June thirtieth, nineteen hundred and three and for other purposes to authorize the imposition of a fee for special events; and to repeal the Law School Clinical Programs Funding Authorization Act of 1978.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Budget Spending Reduction Amendment Act of 1994".

Sec. 2. Special events.

Section 47-2826

- (a) Paragraph 26 of section 7 of An Act Making appropriations to provide for the expenses of the government of the District of Columbia for the fiscal year ending June thirtieth, nineteen hundred and three and for other purposes, approved July 1, 1902 (47 Stat. 554; D.C. Code § 47-2826), is amended as follows:
  - (1) By designating the existing text as subsection (a); and
  - (2) By adding a new subsection (b) to read as follows:
- "(b) The Mayor may adjust the license fee set in subsection (a) of this section to cover the costs to the District of providing police, fire, and other public services that are necessary to protect public health and safety.".
- (b) The Mayor shall establish by rule a schedule of license fees for special events held on public space to cover the costs to the District of providing police, fire, and other public services that are necessary to protect public health and safety.

Sec. 3. Law school clinical program repeal.

Section 31-1901

The Law School Clinical Programs Funding Authorization Act of 1978, effective March 3, 1979 (D.C. Law 2-143; D.C. Code § 31-1901 et seq.), is repealed.

Sec. 4. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in either the District of Columbia Register, the District

of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.

Sec. 2. Special events.
