#### IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To amend the Rental Housing Act of 1985 to change the applicability date of the provision that limits Tenant Assistance Program payments to no more than 60% of the recipient's rent except in the case of elderly or handicapped tenants.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Tenant Assistance Program Payment Limitation Amendment Act of 1993".

Sec. 2. Section 304(b-1)(A) of the Rental Housing Act of 1985, Section effective July 17, 1985 (D.C. Law 6-10; D.C. Code § 45-2534(b-1)(A)), 45-2534 is amended by striking the 2nd sentence and inserting the following sentence in its place to read as follows:

"In the case of persons receiving tenant assistance payments on and before March 17, 1993, and continuously thereafter, this subsection shall apply 2 years from the effective date of the Tenant Assistance Program Payment Limitation Amendment Act of 1993.".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in either the District of Columbia Register, the District

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 10-213 on first and second readings, June 29, 1993, and July 13, 1993, respectively. Following the signature of the Mayor on August 4, 1993, this legislation was assigned Act No. 10-80, published in the August 20, 1993, edition of the <u>D.C. Register</u>, (Vol. 40 page 6049) and transmitted to Congress on September 1, 1993 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 10-45, effective October 21, 1993.

#### IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

#### AUGUST 4, 1993
