#### IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To repeal, on a temporary basis, the sanctions imposed on the Republic of South Africa by the Prohibition of the Investment of Public Funds in Financial Institutions and Companies Making Loans to or Doing Business with the Republic of South Africa or Namibia Act of 1983 and the South Africa and Namibia Contracting Sanction Amendment Act of 1986.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "South Africa Sanctions Temporary Repeal Act of 1993".

Sec. 2. Section 3(c) of the District of Columbia Depository Act of 1977, effective October 26, 1977 (D.C. Law 2-32; D.C. Code § 47-342 47-342(c)), is repealed.

Sec. 3. Section 141(a)(5) of the District of Columbia Retirement
Reform Act, approved November 17, 1979 (93 Stat. 866; D.C. Code § 1-721
1-721(a)(5)), is repealed.

Sec. 4. The District of Columbia Housing Finance Agency Act, effective March 3, 1979 (D.C. Law 2-135; D.C. Code § 45-2101 et seq.), is amended as follows:

(a) Section 406 (D.C. Code § 45-2136) is amended by striking the phrase "and in accordance with section 412".

(b) Section 412 (D.C. Code § 45-2142) is repealed.

Sec. 5. Sections 5, 6, 7, and 8 of the Prohibition of the Investment of Public Funds in Financial Institutions and Companies Making Loans to or Doing Business with the Republic of South Africa or Namibia Act of 1983, effective March 8, 1984 (D.C. Law 5-50; D.C. Code §§ 47-139 through 47-142), are repealed.

Sec. 6. The District of Columbia Procurement Practices Act of 1985, effective February 21, 1986 (D.C. Code § 1-1181.1 et seq.), is amended as follows:

(a) Section 107(2) (D.C. Code § 1-1181.7(2)) is amended by striking after the word "means" the phrase ", for purposes other than those set forth in title Xa,".

(b) Title Xa (D.C. Code § 1-1192.1 et seq.) is repealed.

Sections 1-1192.1 thru 1-1192.6 Sec. 7. Section 3(e) of the Child Abuse and Neglect Prevention Children's Trust Fund Act of 1993, signed by the Mayor on October 1, 1993 (D.C. Act 10-109; 40 DCR \_\_\_\_\_), is repealed.

Sec. 8. Effective date.

- (a) This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code §1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
- (b) This act shall expire on the 225th day of its having taken effect or upon the effective date of the South Africa Sanctions Repeal Act of

1993, whichever occurs first.

Following the signature of the Mayor on November 4, 1993, pursuant to Section 404(e) of "the Act", and was assigned Act No. 10-142, published in the November 19, 1993, edition of the <u>D.C. Register</u>, (Vol. 40 page 8072) and transmitted to Congress on November 15, 1993 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 10-75, effective March 8, 1994.

#### IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

#### NOVEMBER 4, 1993

To repeal, on a temporary basis, the sanctions imposed on the Republic of South Africa by the Prohibition of the Investment of Public Funds in Financial Institutions and Companies Making Loans to or Doing Business with the Republic of South Africa or Namibia Act of 1983 and the South Africa and Namibia Contracting Sanction Amendment Act of 1986.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "South Africa Sanctions Temporary Repeal Act of 1993".

Sec. 2. Section 3(c) of the District of Columbia Depository Act of Section 1977, effective October 26, 1977 (D.C. Law 2-32; D.C. Code § 47-342 47-342(c)), is repealed.

Sec. 3. Section 141(a)(5) of the District of Columbia Retirement
Reform Act, approved November 17, 1979 (93 Stat. 866; D.C. Code § 1-721
1-721(a)(5)), is repealed.

Sec. 4. The District of Columbia Housing Finance Agency Act, effective March 3, 1979 (D.C. Law 2-135; D.C. Code § 45-2101 et seq.), is amended as follows:

(a) Section 406 (D.C. Code  $\S$  45-2136) is amended by striking the phrase "and in accordance with section 412".

(b) Section 412 (D.C. Code § 45-2142) is repealed.

Sec. 5. Sections 5, 6, 7, and 8 of the Prohibition of the Investment of Public Funds in Financial Institutions and Companies Making Loans to or Doing Business with the Republic of South Africa or Namibia Act of 1983, effective March 8, 1984 (D.C. Law 5-50; D.C. Code §§ 47-139 through 47-142), are repealed.

Sec. 6. The District of Columbia Procurement Practices Act of 1985, effective February 21, 1986 (D.C. Code § 1-1181.1 et seq.), is amended as follows:

(a) Section 107(2) (D.C. Code § 1-1181.7(2)) is amended by striking after the word "means" the phrase ", for purposes other than those set forth in title Xa,".

(b) Title Xa (D.C. Code § 1-1192.1 et seq.) is repealed.

Sec. 8. Effective date.

- (a) This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code §1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
- (b) This act shall expire on the 225th day of its having taken effect or upon the effective date of the South Africa Sanctions Repeal Act of 1993, whichever occurs first.
