D.C. LAW 10-78

"Alternative Fuels Technology Amendment Act of 1993".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 10-47 on first and second readings, October 5, 1993, and November 2, 1993, respectively. Following the signature of the Mayor on November 17, 1993, this legislation was assigned Act No. 10-151, published in the December 10, 1993, edition of the <u>D.C.</u> <u>Register</u>, (Vol. 40 page 8464) and transmitted to Congress on November 24, 1993 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 10-78, effective March 17, 1994.

D.C. ACT 10-151

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

NOVEMBER 17, 1993

To amend the Alternative Fuels Technology Act of 1990 to extend the deadline for the submission of an exemption report by the Mayor, the submission of a comprehensive plan by each owner or operator of a commercial fleet, the requirement that an owner or operator of a commercial fleet utilize by conversion or procurement a percentage of motor vehicles powered by clean alternative fuels, and issuance of the rules to implement the provisions of the act, for 2 years beyond the present requirements.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Alternative Fuels Technology Amendment Act of 1993".

Sec. 2. The Alternative Fuels Technology Act of 1990, effective March 8, 1991 (D.C. Law 8-243; D.C. Code 40-2001 *et seq.*), is amended as follows:

(a) Section 3(b) (D.C. Code § 40-2002(2)) is amended by striking the year "1991" and inserting the year "1993" in its place.

(b) Section 4 (D.C. Code § 40-2003) is amended as follows:

(1) Subsection (a) is amended by striking the year "1992" and Not inserting the year "1994" in its place.

(2) Subsection (b) is amended as follows:

(A) Paragraph (1) is amended by striking the year "1993" and inserting the year "1995" in its place.

(B) Paragraph (2) is amended by striking the year "1994" and inserting the year "1996" in its place.

(C) Paragraph (3) is amended by striking the year "1995" and inserting the year "1997" in its place.

(D) Paragraph (4) is amended by striking the year "1996" and inserting the year "1998" in its place.

(E) Paragraph (5) is amended by striking the year "1997" and inserting the year "1999" in its place.

(F) Paragraph (6) is amended by striking the year "1998" and inserting the year "2000" in its place.
(G) Paragraph (7) is amended by striking the year "1999"

and inserting the year "2001" in its place. (H) Paragraph (8) is amended by striking the year "2000"

and inserting the year "2002" in its place.

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
