Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 11-292 on first and second readings, February 6, 1996 and March 5, 1996 respectively. Following the signature of the Mayor on March 15, 1996, pursuant to Section 404(e) of "the Act", and was assigned Act No. 11-231 and published in the March 29, 1996, edition of the D.C. Register (Vol. 43 page 1546) and transmitted to Congress on March 29, 1996 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 11-124, effective May 24, 1996.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

MARCH 15, 1996

To amend the District of Columbia Traffic Act, 1925 to increase the fee for a learner's permit and extend the validation period.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Learner's Permit Amendment Act of 1996".

Sec. 2. Section 7(a)(2) of the District of Columbia Traffic Act, 1925, approved March 3, section 1925 (43 Stat. 1121; D.C. Code § 40-301(a)(2)), is amended by striking the phrase "a fee of \$10, issue a learner's permit, valid for a period of 60 days," and by inserting the phrase "a fee of \$15, issue a learner's permit, valid for a period of 6 months," in its place.

Sec. 3. Fiscal impact statement.

The Council adopts the fiscal impact statement in the committee report as the fiscal impact statement required by section 602(c)(3) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(3)).

Sec. 4. This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), approval by the Financial Responsibility and Management Assistance Authority as provided in section 203(a) of the District of Columbia Financial Responsibility and Management Assistance Authority Act of 1995, approved April 17, 1995 (109 Stat. 116; D.C. Code § 47-392.3(c)), and a 30-day period of Congressional review as provided in section 602(c)(1) of the District of Columbia Self-
