IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JULY 22, 1996

To amend the District of Columbia Right to Overnight Shelter Act of 1984 and the District of Columbia Public Assistance Act of 1982 to clarify the circumstances under which the District of Columbia government claims federal financial participation.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the "Emergency Assistance Clarification Amendment Act of 1996".

Sec. 2. Section 3a (5) of the District of Columbia Right to Overnight Shelter Act of 1984, effective March 6, 1991 (D.C. Law 8-197; D.C. Code § 3-602.1(e)), is amended by striking the word "shall" and inserting the word "may" in its place.

Sec. 5. This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), approval by the Financial Responsibility and Management Assistance Authority as provided in section 203(a) of the District of Columbia Financial Responsibility and Management Assistance Authority Act of 1995, approved April 17, 1995 (109 Stat. 116; D.C. Code § 47-392.3(a)), and a 30-day period of Congressional review as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in the District of Columbia Register.
