" Public Accountancy Amendment Act of 1995".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 11-55 on first and second readings, May 2, 1995 and June 6, 1995, respectively. Following the signature of the Mayor on June 19, 1995, pursuant to Section 404(e) of "the Act", and was assigned Act No. 11-73 and published in the June 30, 1995, edition of the D.C. Register (Vol. 42 page 3275) and transmitted to Congress on June 22, 1995 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 11-40, effective September 8, 1995.

AN ACT

D.C. ACT 11-73

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JUNE 19, 1995

To amend the District of Columbia Public Accountancy Act of 1977 to change the education requirement necessary for certification as a public accountant for applicants receiving a baccalaureate degree after January 1, 2000.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Public Accountancy Amendment Act of 1995".

Sec. 2. Section 8(a)(5) of the District of Columbia Public Accountancy Act of 1977, Section effective March 16, 1978 (D.C. Law 2-59; D.C. Code § 2-107(a)(5)), is amended by adding a new subparagraph (C) to read as follows:

"(C) For applicants receiving a baccalaureate degree after January 1, 2000, in addition to meeting the requirements of either subparagraph (A) or (B) of this paragraph, possesses 150 semester hours of college education.".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat.
