"Prohibition on the Transfer of Firearms Act of 1995".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 11-234 on first and second readings, June 6, 1995 and June 20, 1995, respectively. Following the signature of the Mayor on July 10, 1995, pursuant to Section 404(e) of "the Act", and was assigned Act No. 11-92 and published in the July 21, 1995, edition of the D.C. Register (Vol. 42 page 3680) and transmitted to Congress on July 13, 1995 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 11-50, effective September 22, 1995.

AN ACT D.C. ACT 11-92

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JULY 10, 1995

To prohibit the transfer by the Metropolitan Police Department of any ammunition feeding device.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Prohibition on the Transfer of Firearms Act of 1995".

Sec. 2. Except as provided in section 705 of the Firearms Control Regulations Act of 1975, effective September 24, 1976 (D.C. Law 1-85; D.C. Code § 6-2375), and section 18 of An Act to control the possession, sale, transfer, and use of pistols and other dangerous weapons in the District of Columbia, to provide penalties, to prescribe rules of evidence, and for other purposes, approved February 20, 1952 (66 Stat. 8; D.C. Code § 22-3217), the Metropolitan Police Department shall not transfer any ammunition feeding device in its possession to any person or entity other than a law enforcement officer or governmental agency for law enforcement purposes.

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24,
