"Extension of the Moratorium on Retail Service Station Conversions Temporary Amendment Act of 1995".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 11-378 on first and second readings, July 11, 1995 and July 29, 1995 respectively. Following the signature of the Mayor on August 9, 1995, pursuant to Section 404(e) of "the Act", and was assigned Act No. 11-131 and published in the August 18, 1995, edition of the D.C. Register (Vol. 42 page 4330) and transmitted to Congress on August 15, 1995 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 11-68, effective October 26, 1995.

## IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

# AUGUST 9, 1995

To amend, on a temporary basis, the Retail Service Station Act of 1976 to extend the moratorium on the conversion of full service retail service stations to limited service retail service stations until October 1, 1999, and extend the life of the Gas Station Advisory Board.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Extension of the Moratorium on Retail Service Station Conversions Temporary Amendment Act of 1995".

Sec. 2. Section 5-301 of the Retail Service Station Act of 1976, effective April 19, 1977 (D.C. Law 1-123; D.C. Code § 10-231), is amended as follows:

- (a) Subsection (b) is amended by striking the phrase "October 1, 1995" and inserting the phrase "October 1, 1999" in its place.
- (b) Subsection (c) is amended by striking the phrase "October 1, 1995" and inserting the phrase "October 1, 1999" in its place.
- (c) Subsection (e)(4) is amended by striking the phrase "October 1, 1995" and inserting the phrase "October 1, 1999" in its place.
- Sec. 3. (a) This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.

(b) This act shall expire after 225 days of its having taken effect or upon the effective date of the Extension of the Moratorium on Retail Service Station Conversions Amendment Act of 1995, whichever comes first.
