IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

DECEMBER 22, 1997

To amend the Law to Legalize Lotteries, Daily Numbers Games, and Bingo and Raffles for Charitable Purposes in the District of Columbia to make stylistic and punctuation corrections; to amend Title 23 of the District of Columbia Code to make stylistic and spelling corrections; and to amend the Prison Industries Act of 1996 to make a stylistic correction.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Criminal Code Technical Amendments Act of 1997".

Sec. 4. Section 10 of Prison Industries Act of 1996, effective May 8, 1996 (D.C. Law 11-117; D.C. Code § 24-458.9), is amended by striking the phrase "(a) Prisoners" and inserting the phrase "Prisoners" in its place.

Sec. 5. This act shall have no fiscal impact.
