# IN THE COUNCIL OF THE DISTRICT OF COLUMBIA MARCH 17, 1998

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Omnibus Sports Consolidation Amendment Act of 1998".

Code § 2-4001 et seq.), is amended by striking the phase "District of Columbia Sports Commission" and inserting the phrase "District of Columbia Sports and Entertainment Commission" in its place wherever it appears and by striking the phrase "Sports Commission" and inserting the phrase "Sports and Entertainment Commission" in its place wherever it appears.
