

D.C. LAW 12-13

"Motor Vehicle Biennial Inspection Fund Act of 1997".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 12-18, on first and second readings, March 4, 1997 and May 6, 1997, respectively. Following the signature of the Mayor on May 23, 1997, pursuant to Section 404(e) of "the Act", and was assigned Act No. 12-90, and published in the June 27, 1997, edition of the D.C. Register (Vol. 44 page 3618) and transmitted to Congress on June 18, 1997 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 12-13, effective September 5, 1997.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

MAY 23, 1997

To amend An Act To provide for the annual inspection of all motor vehicles in the District of Columbia to establish a dedicated fund for the District of Columbia Enhanced Vehicle Emissions Inspection Program as mandated by the Federal Clean Air Act Amendments of 1990.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Motor Vehicle Biennial Inspection Fund Act of 1997".

Sec. 2. Section 2 of An Act To provide for the annual inspection of all motor vehicles in the District of Columbia, approved February 18, 1938 (52 Stat. 78; D.C. Code § 40-202), is amended to read as follows:

"Sec 2.

- "(a)(1) There is hereby established the District of Columbia Motor Vehicle Biennial Inspection Fund ("the Fund"). The Fund shall be a revolving fund and not be a part of nor lapse into the General Fund of the District or any other fund of the District.
- "(2) The Fund shall be classified as a governmental fund and shall be accounted for in accordance with the District of Columbia Fund Accounting Act of 1980, effective June 14, 1980 (D.C. Law 3-70; D.C. Code § 47-371 *et seq.*), and any other applicable law.
 - "(b) The Mayor shall administer the Fund to finance the following:
- "(1) The implementation, oversight, operation, and periodic upgrading of the District of Columbia's Enhanced Vehicle Emissions Inspection Program and its vehicle safety inspection program; and
- "(2) The purchase, maintenance, and upgrading of equipment; program administration; technical skills training; contracts for services; and any other activities necessary to comply with federal and District of Columbia vehicle emissions and safety inspections legislative mandates.
- "(c) The inspection fee levied and collected pursuant to section 1 of An Act To provide for the annual inspection of all motor vehicles in the District of Columbia, approved February 18, 1938 (52 Stat. 78; D.C. Code § 40-201), shall be established in an amount sufficient to

cover the costs of implementation, operation, and periodic upgrading of the District of Columbia's vehicle emissions and safety inspection programs, and shall be deposited into the Fund. The Mayor may, from time to time, adopt rules that adjust the inspection fee as necessary to compensate the District for the cost of implementing, overseeing, operating, and upgrading the vehicle emissions and safety inspection programs, and such adjustments shall be made in accordance with an evaluation of the annual audited accounting required by subsection (d) of this section.

"(d) Obligations and expenditures of amounts from the Fund shall be based on an annual appropriation approved by Congress following the submission of a budgetary request by the Mayor. As part of the Mayor's annual budgetary request, the Mayor shall submit an audited accounting of the use of the Fund during the previous fiscal year.".

Sec. 3. Fiscal impact statement.

The Council adopts the fiscal impact statement in the committee report as the fiscal impact statement required by section 602(c)(3) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(3)).

Sec. 4. This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), approval by the Financial Responsibility and Management Assistance Authority as provided in section 203(a) of the District of Columbia Financial Responsibility and Management Assistance Act of 1995, approved April 17, 1995 (109 Stat. 116; D.C. Code § 47-392.3(a)), a 30-day period of Congressional review as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(201)), and publication in the District of Columbia Register.
