### D.C. LAW 12-133

"Eastern Market Open Air Retailing Temporary Act of 1998"

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 12-573, on first and second readings, March 3, 1998 and April 7, 1998, respectively. Following the signature of the Mayor on April 20, 1998, pursuant to Section 404(e) of "the Act", and was assigned Act No. 12-333 and published in the May 15, 1998, edition of the D.C. Register (Vol. 45 page 2933) and transmitted to Congress on May 19, 1998 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 12-133, effective July 24, 1998.

### IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

APRIL 20, 1998

To permit, on a temporary basis, the interim continuation of non-food open air retailing in the exterior space at Eastern Market that is not otherwise leased.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Eastern Market Open Air Retailing Temporary Act of 1998".

Sec. 2. Consistent with past practices of a Saturday Arts and Crafts Festival and Sunday Flea Market in the North Hall of Eastern Market and the adjacent public space exterior to the North Hall, as designated in the April 29, 1982, April 16, 1987, and December 27, 1995, space sub-assignments from the Commission on Arts and Humanities ("Sub-assignments"), the Department of Administrative Services may permit open air non-food retailing activities in the same manner and under the same limits and rules as these activities existed as of November 30, 1997. No open air retailing shall be permitted in the interior or exterior space that is designated in the 1966 lease between Eastern Market Corporation and the Department of Administrative Services without the agreement of the lessee, Eastern Market Corporation.

Code § 1-233(c)(1)), and publication in the District of Columbia Register.
