"Uniform Controlled Substances Amendment Act of 1998

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 12-213 on first and second readings, March 3, 1998 and April 7, 1998, respectively. Following the signature of the Mayor on April 20, 1998, pursuant to Section 404(e) of "the Act", and was assigned Act No. 12-337 and published in the May 15, 1998, edition of the D.C. Register (Vol. 45 page 2942) and transmitted to Congress on May 19, 1998 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 12-136, effective July 24, 1998.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA APRIL 20, 1998

To amend the District of Columbia Uniform Controlled Substances Act of 1981 to give the Mayor rulemaking authority regarding the scheduling of controlled substances, to clarify the authority of registrants of controlled substances, and to expand enforcement authority.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Uniform Controlled Substances Amendment Act of 1998".

- Sec. 2. The District of Columbia Uniform Controlled Substances Act of 1981, effective August 5, 1981 (D.C. Law 4-29; D.C. Code § 33-501 *et seq.*) is amended as follows:
 - (a) Section 201(b) (D.C. Code § 33-511(b)) is amended as follows:

Section 33-511

- (1) Paragraph (1) is amended by striking the paragraph designation (1) and by striking the word "proposed";
 - (2) Paragraphs (2), (3), (4), and (5) are repealed.
- (b) Section 302(b) (D.C. Code § 33-532(b)) is amended by adding a new sentence to the end to read as follows: "Any person registered under this act whose authority to possess, distribute, dispense, or conduct research with controlled substances is limited or otherwise restricted by any federal, state, or District of Columbia law, shall use such registration only to the extent authorized by said federal, state, or District of Columbia law unless otherwise specified.".

- (c) Section 304(a) (D.C. Code § 33-534(a)) is amended as follows:
 - (1) Paragraph (2) is amended by striking the word "or" at the end.

Section 33-534

- (2) Paragraph (3) is amended by striking the period at the end and inserting the phrase "; or" in its place.
 - (3) A new paragraph (4) is added to read as follows:
 - "(4) has violated any provisions of this act.".
- Sec. 3. The Council adopts the fiscal impact statement in the committee report as the fiscal impact statement required by section 602(c)(3) of the District of Columbia Home Rule

Code § 47-392.3(a)), a 30-day period of Congressional review as provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in the District of Columbia Register.
