# **D.C. LAW 12-182**

# "Public School Nurse Assignment Temporary Amendment Act of 1998"

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 12-739, on first and second readings, July 30, 1998 and September 22, 1998, respectively. Following the signature of the Mayor on October 1, 1998, pursuant to Section 404(e) of "the Act", and was assigned Act No. 12-453 and published in the October 16, 1998, edition of the D.C. Register (Vol. 45 page 7449) and transmitted to Congress on January 25, 1999 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 12-182, effective March 26, 1999.

# D.C. ACT 12-453

# IN THE COUNCIL OF THE DISTRICT OF COLUMBIA OCTOBER 1, 1998

To amend, on a temporary basis, the District of Columbia Public School Nurse Assignment Act of 1987 to indicate the level of medical coverage required at District of Columbia Public School varsity and non-varsity interscholastic football games held in the District of Columbia.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Public School Nurse Assignment Temporary Amendment Act of 1998".

Sec. 2. Section 2(e)(1)(A) of the District of Columbia Public School Nurse Assignment Note, Section Act of 1987, effective December 10, 1987 (D.C. Law 7-45; D.C. Code § 31-2421(e)(1)(A)), is amended to read as follows:

"(A) For varsity football, a licensed medical doctor and for non-varsity football, a licensed medical doctor or certified athletic trainer;".

Sec. 3. This act shall have no fiscal impact.

Sec. 4. (a) This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), approval by the Financial Responsibility and Management Assistance Authority as provided in section 203(a) of the District of Columbia Financial Responsibility and Management Assistance Act of 1995, approved April 17, 1995 (109 Stat. 116; D.C. Code § 47-392.3(a)), a 30-day period of Congressional review as provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in the District of Columbia Register.
