#### "General Public Assistance Program Termination Temporary Amendment Act of 1997".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 12-169, on first and second readings, May 6, 1997 and June 3, 1997, respectively. Following the signature of the Mayor on June 18, 1997, pursuant to Section 404(e) of "the Act", and was assigned Act No. 12-98, and published in the July 18, 1997, edition of the D.C. Register (Vol. 44 page 4028) and transmitted to Congress on July 11, 1997 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 12-21, effective September 23, 1997.

### IN THE DISTRICT OF COLUMBIA JUNE 18, 1997

To amend, on a temporary basis, the District of Columbia General Public Assistance Act of 1982 to terminate the General Public Assistance program.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "General Public Assistance Program Termination Temporary Amendment Act of 1997."
