IN THE COUNCIL OF THE DISTRICT OF COLUMBIA JUNE 18, 1997

To amend the Washington Convention Center Authority Act of 1994 to provide for coverage of the Washington Convention Center employees by the Public Employee Relations Board and by the labor-management relations title of the District of Columbia Government Comprehensive Merit Personnel Act of 1978.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Washington Convention Center Authority Collective Bargaining Amendment Act of 1997".

Sec. 2. Section 216 of the Washington Convention Center Authority Act of 1994, effective September 28, 1994 (D.C. Law 10-188; D.C. Code § 9-817), is amended by striking the period and inserting the phrase ", except that titles V and XVII of the District of Columbia Government Comprehensive Merit Personnel Act of 1978, effective March 3, 1979 (D.C. Law 22-139; D.C. Code §§ 1-605.1 *et seq.* and 1-618.1 *et seq.*), shall apply." in its place.

Sec.3. Fiscal impact statement.

The Council adopts the fiscal impact statement in the committee report as the fiscal impact statement required by section 602(c)(3) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(3)).

Sec. 4. This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), approval by the Financial Responsibility and Management Assistance Authority as provided in section 203(a) of the District of Columbia Financial Responsibility and Management Assistance Act of 1995, approved April 17, 1995 (109 Stat. 116; D.C. Code § 47-392.3(a)), a 30-day period of Congressional review as provided in section 602(c)(1) of the District of Columbia Self-
