### "Hazardous Duty Compensation for Metropolitan Police Department Scuba Divers Amendment Act of 1998"

Pursuant to Section 412 of the District of Columbia Home Rule Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill 12-142 on first and second readings, December 1, 1998 and December 15, 1998, respectively. Following the signature of the Mayor on December 29, 1998, pursuant to Section 404(e) of "the Act", the bill became Act 12-593 and it was published in the February 12, 1999 edition of the D.C. Register (Vol. 46, page 1127). The Act was transmitted to Congress on February 10, 1999 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional review period has expired, and the Act is now D.C. Law 12-252, effective April 20, 1999.

# IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

## DECEMBER 29, 1998

To amend the District of Columbia Police and Firemen's Salary Act of 1958 to authorize hazardous duty compensation for Metropolitan Police Department scuba divers.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Hazardous Duty Compensation for Metropolitan Police Department Scuba Divers Amendment Act of 1998".

Sec. 2. Section 202 of the District of Columbia Police and Fireman's Salary Act of 1958, approved August 1, 1958 (72 Stat. 483; D.C. Code § 4-408), is amended as follows:

Section 4-408

- (a) The section heading is amended to read as follows:
- "Sec. 202. Additional compensation for helicopter pilot, bomb disposal, or scuba diving duty.".
  - (b) A new sentence is added after the first sentence to read as follows:
- "Further, each officer or member of the metropolitan police force assigned on or after August 29, 1972 to the Harbor Patrol division within the Metropolitan Police Department as scuba divers shall receive in addition to his or her scheduled rate of basic compensation, \$2,710.00 per annum so long as he or she remains in such assignment."
- Sec. 3. The Council adopts the fiscal impact statement in the committee report as the fiscal impact statement required by section 602(c)(3) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(3)).
- Sec. 4. This act shall take effect upon its approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), approval by the Financial Responsibility and Management Assistance Authority as provided in section 203(a) of the Financial Responsibility and Management Assistance Act of 1995, approved April 17, 1995 (109 Stat. 116; D.C. Code § 47-392.3(a)), a 30-day period of Congressional review as provided in
