### D.C. LAW 12-258

## "Home and Community Juvenile Probation Supervision Act of 1998"

Pursuant to Section 412 of the District of Columbia Home Rule Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill 12-596 on first and second readings, December 1, 1998 and December 15, 1998, respectively. Following the signature of the Mayor on December 31, 1998, pursuant to Section 404(e) of "the Act", the bill became Act 12-610 and it was published in the February 19, 1999 edition of the D.C. Register (Vol. 46, page 1314). The Act was transmitted to Congress on February 10, 1999 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional review period has expired, and the Act is now D.C. Law 12-258, effective April 20, 1999.

#### AN ACT

# D.C. ACT 12-610

#### IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

#### DECEMBER 31, 1998

To amend Title 16 of the District of Columbia Code to permit the Director of Social Services for the Family Division of the Superior Court of the District of Columbia to take juveniles into custody where it reasonably appears that they have violated a term of their probation.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Home and Community Juvenile Probation Supervision Act of 1998".

Sec. 2. Title 16 of the District of Columbia Code is amended as follows:

(a) Section 16-2309(a) is amended as follows:

(1) Strike the word "or" at the end of paragraph (6).

(2) Strike the period at the end of paragraph (7) and insert the phrase "; or" in its

place.

(3) A new paragraph (8) is added to read as follows:

"(8) by the Director of Social Services, pursuant to section 16-2337.".

(b) Section 16-2337 is amended by inserting the phrase "children on probation and under Section the Director's supervision, when the Director has reasonable cause to believe they have violated 16-2337 one or more conditions of their probation," after the phrase, "or neglected,".

Sec. 3. Nongermane amendment.

Section 5 of the Harris/Hinton Place and Bishop Samuel Kelsey Way Designation Act of 1998, passed on second reading on December 15, 1988 (Enrolled version of Bill 12-234), is amended as follows:

(a) Strike the phrase "The Council" and insert the phrase "(a) For the purposes of section 3 of this act, the Council" in its place.

(b) Add a new subsection (b) to read as follows:

"(b) Section 4 of this act will have minimal fiscal impact other than the one-time cost of fabricating new signs for the 1400 through 1600 blocks of Park Road, N.W.".

Sec. 4. With regard to section 2 of this act, the Council adopts the fiscal impact statement in the committee report as the fiscal impact statement required by section 602(c)(3) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(3)).

Sec. 5. This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), approval by the Financial Responsibility and Management Assistance Authority as provided in section 203(a) of the District of Columbia Financial Responsibility and Management Assistance Act of 1995, approved April 17, 1995 (109 Stat. 116; D.C. Code § 47-392.3(a)), a 30-day period of Congressional review as provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in the District of Columbia Register.
