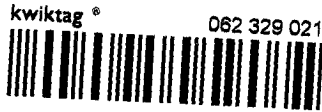

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA
DECEMBER 24, 1998

To amend the Sex Offender Registration Act of 1996 to allow for risk assessments, recommendations, and mental examinations to be made of all offenders who are required to register under the act.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Sex Offender Registration Risk Assessment Clarification Amendment Act of 1998".

Sec. 2. Section 18 of the Sex Offender Registration Act of 1996, effective June 3, 1997 (D.C. Law 11-274; D.C. Code § 24-1117), is amended by adding a new subsection (c) to read as follows: Section 24-1117

"(c) Notwithstanding any other provision of this act, and subject to the availability of funds, the Court may at any time:

"(1) Direct the Advisory Council to make an assessment and recommendation concerning any offender who is required to register under this act;

"(2) Order a mental examination of any offender who is required to register under this act, for the purpose of assessing risk under the provisions of this act; and

"(3) Make the determinations described in section 6(3)(D), in conformity with section 6(3)(A)-(C)."

Sec. 3. Fiscal impact statement.



Sec. 4. Effective date.




