IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

DECEMBER 24, 1998

To amend the Sex Offender Registration Act of 1996 to allow for risk assessments, recommendations, and mental examinations to be made of all offenders who are required to register under the act.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Sex Offender Registration Risk Assessment Clarification Amendment Act of 1998".

Sec. 2. Section 18 of the Sex Offender Registration Act of 1996, effective June 3, 1997 (D.C. Law 11-274; D.C. Code § 24-1117), is amended by adding a new subsection (c) to read as ²⁴⁻¹¹¹⁷ follows:

"(c) Notwithstanding any other provision of this act, and subject to the availability of funds, the Court may at any time:

"(1) Direct the Advisory Council to make an assessment and recommendation concerning any offender who is required to register under this act;

"(2) Order a mental examination of any offender who is required to register under this act, for the purpose of assessing risk under the provisions of this act; and

"(3) Make the determinations described in section 6(3)(D), in conformity with section 6(3)(A)-(C).".

Sec. 3. Fiscal impact statement.

The Council adopts the fiscal impact statement in the committee report as the fiscal impact statement required by section 602(c)(3) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(3)).

Sec. 4. Effective date.

This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), approval by the Financial Responsibility and Management Assistance Authority as provided in section 203(a) of the District of Columbia
