## **D.C. LAW 12-34**

"Real Property Interests Reporting Improvement Amendment Act of 1997".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 12-177, on first and second readings, June 17, 1997 and July 1, 1997, respectively. Following the signature of the Mayor on July 17, 1997, pursuant to Section 404(e) of "the Act", and was assigned Act No. 12-130, and published in the August 22, 1997, edition of the D.C. Register (Vol. 44 page 4827) and transmitted to Congress on September 3, 1997 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 12-34, effective October 23, 1997.

# AN ACT

# D.C. ACT 12-130

Codification District of Columbia Code 1998 Supp.

## IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

## JULY 17, 1997

To amend An Act To establish a code of law for the District of Columbia to require the owner, mortgagee, secured party under a deed of trust, trustee, and lienholder of any real property to notify the Recorder of Deeds when there is a name or address change, and to authorize an administrative fee to cover the cost of additional research to locate an owner, a mortgagee, a secured party under a deed of trust, a trustee, or a lienholder after an unsuccessful attempt using available information.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Real Property Interests Reporting Improvement Amendment Act of 1997".

Sec. 2. Chapter 16 of An Act To establish a code of law for the District of Columbia, approved March 3, 1901 (31 Stat. 1267; D.C. Code § 45-301 *passim*), is amended by adding a new section 499d to read as follows:

"499d. Notice of address and name change.

"(a) All parties with an interest in a particular real property (including owners of the real property, mortgagees, secured parties under a deed of trust, trustees, or lienholders) shall notify the Recorder of Deeds in writing in the event of a name change or address change. The notice shall identify the real property and specify the interest held in the property. A person to whom an interest in a particular real property has been transferred shall provide their full name and address when recording the interest.

"(b) The Recorder of Deeds shall enter into its land records all updated information received according to subsection (a) of this section.

"(c) The District shall assess a fee not to exceed \$300 against an interested party if the District is unable to locate the interested party using all available information in the land records at the Office of the Recorder of Deeds or other information available at the Department of Finance and Revenue.

"(d) The Mayor shall issue rules to implement this section.".

Sec. 3. The Council adopts the fiscal impact statement in the committee report as the fiscal impact statement required by section 602(c)(3) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(3)).

Sec. 4. Effective date.

This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), approval by the Financial Responsibility and Management Assistance Authority as provided in section 203(a) of the District of Columbia Financial Responsibility and Management Assistance Act of 1995, approved April 17, 1995 (109 Stat. 116; D.C. Code § 47-392.3(a)), a 30-day period of Congressional review as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in the District of Columbia Register.
