"CFO Membership on the Health and Hospitals Public Benefit Corporation Board, Council Review of Board Promulgations, and Approval of Organizational and Operational Plan Amendment Act of 1997".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 12-109, on first and second readings, June 17, 1997, and July 1, 1997, respectively. Following the signature of the Mayor on July 17, 1997, pursuant to Section 404(e) of "the Act", and was assigned Act No. 12-127, and published in the October 10, 1997, edition of the D.C. Register (Vol. 44 page 5763) and transmitted to Congress on October 3, 1997 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 12-43 effective February 6, 1998.

D.C. ACT 12-127

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA JULY 17, 1997

To amend the Health and Hospitals Public Benefit Corporation Act of 1996 to add the Chief Financial Officer of the District of Columbia as an *ex officio* voting member of the Board of the Health and Hospitals Public Benefit Corporation and to provide for Council review of Board promulgations, and to approve the Board's organizational and operational plan.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "CFO Membership on the Health and Hospitals Public Benefit Corporation Board, Council Review of Board Promulgations, and Approval of Organizational and Operational Plan Amendment Act of 1997".

Sec. 2. The Health and Hospitals Public Benefit Corporation Act of 1996, effective April 9, 1997 (D.C. Law 11-212; D.C. Code § 32-261.1 *et seq.*), is amended as follows: (a) Section 203(a) (D.C. Code § 32-262.3(a)) is amended as follows:

(1) By striking the number "12" and inserting the number "13" in its place; and

(2) By inserting the sentence "The Chief Financial Officer of the District of Columbia shall serve as an *ex officio* voting member." after the second sentence.

(b) Section 207(a) (D.C. Code § 3-262.7(a)) is amended by adding a new paragraph (3A) to read as follows:

"(3A) The Board shall submit the policies, practices, procedures, and regulations that it promulgates and issues pursuant to paragraphs (2) and (3) of this subsection, consistent with the District of Columbia Financial Plan and Budget, to the Council by September 16, 1997, for a 45-day period of review excluding Saturdays, Sundays, legal holidays, and days of Council recess. If the Council does not approve or disapprove the policies, practices, procedures, or regulations, in whole or in part, by resolution within the 45-day review period, the policies, practices, procedures, or regulations shall be deemed approved.".

Sec. 3. Pursuant to section 207(a)(1) of the Health and Hospitals Public Benefit Corporation Act of 1996, effective April 9, 1997 (D.C. Law 11-212; D.C. Code § 32-

262.7(a)(1)), the Council has reviewed and approves the Organizational and Operational Plan for the District of Columbia Health and Hospitals Public Benefit Corporation; provided, that the Chief Financial Officer certifies that the Organizational and Operational Plan is consistent with the District of Columbia Financial Plan and Budget.

Sec. 4. Enactment of this legislation will have no negative fiscal impact. Members of the PBC Board receive no compensation. Council approval of the Organizational and Operational Plan is contingent upon the Chief Financial Officer's certifying that the Plan is consistent with the District's Financial Plan and Budget. In addition, the PBC's procurement and personnel regulations are required to be consistent with the District's Financial Plan Budget.

Sec. 5. This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), approval by the Financial Responsibility and Management Assistance Authority as provided in section 203(a) of the District of Columbia Financial Responsibility and Management Assistance Act of 1995, approved April 17, 1995 (109 Stat. 116; D.C. Code § 47-392.3(a)), a 30-day period of Congressional review as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233($\mathcal{O}(1)$), and publication in the District of Columbia Register.
