D.C. LAW 12-50

"Small Purchase Authority Amendment Act of 1997"

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 12-231 on first and second readings, July 1, 1997, and September 22, 1997, respectively. Following the signature of the Mayor on October 3, 1997, pursuant to Section 404(e) of "the Act", and was assigned Act No. 12-164, and published in the October 31, 1997, edition of the D.C. Register (Vol. 44 page 6222) and transmitted to Congress on October 23, 1997 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 12-50, effective February 27, 1998.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

OCTOBER 3, 1997

To amend the Procurement Practices Act of 1985 to reestablish small purchase authority.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Small Purchase Authority Amendment Act of 1997".

Sec. 2. The District of Columbia Procurement Practices Act of 1985, effective February 21, 1986 (D.C. Law 6-85; D.C. Code § 1-1181.1 *et seq.*), is amended as follows:

(a) Section 320 is amended by adding a new subsection (j) that reads as follows:

Section
1-1183.2

"(j) Nothing in this act shall affect the District of Columbia Water and Sewer Authority's powers to establish and operate its procurement system and to execute contracts pursuant to the Water and Sewer Authority Establishment and Department of Public Works Reorganization Act of 1996, effective April 18, 1996 (D.C. Law 11-111; D.C. Code § 43-1661 *et seq.*)."

(b) A new section 321 is added to read as follows:

New Section
1-1183.21

"321. Small purchase procurement.

"Special small purchase procedures may be used by the Chief Procurement Officer or his or her designee, in accordance with regulations established pursuant to this act, for procurements not exceeding \$25,000. Procurement requirements shall not be parceled, split, divided, or purchased over a period of time in order not to exceed the dollar limitation for use of these small purchase procedures. An employee who violates the provisions of this subsection shall be subject to suspension, dismissal, or other disciplinary action pursuant to District law."


Sec. 3. Fiscal impact statement.

The Council adopts the fiscal impact statement in the Committee report on Bill 12-231 as the fiscal impact statement required by section 602(c)(3) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 913; D.C. Code § 1-233 (c)(3)).



Sec. 4. Effective date.

This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), approval by the Financial Responsibility and Management Assistance Authority as provided in section 203(a) of the District of Columbia Financial Responsibility and Management Assistance Act of 1995, approved April 17, 1995 (109 Stat. 116; D.C. Code § 47-392.3(a)), a 30-day period of Congressional review as provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in the District of Columbia Register.
