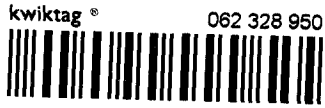

### D.C. LAW 12-91

#### **"Advisory Neighborhood Commissions Quorum Definition Amendment Act of 1998"**

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P.L. 93-198 "the Act", the Council of the District of Columbia adopted Bill No. 12-263, on first and second readings, December 4, 1997 and January 6, 1998, respectively. Following the signature of the Mayor on January 26, 1998, pursuant to Section 404(e) of "the Act", and was assigned Act No. 12-264, and published in the March 13, 1998, edition of the D.C. Register (Vol. 45 page1314) and transmitted to Congress on February 27, 1998 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 12-91, effective April 29, 1998.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JANUARY 26, 1998

To amend the Advisory Neighborhood Commissions Act of 1975 to permit Advisory Neighborhood Commissions to declare a quorum and transact business when a majority of the elected representatives is present, provided that a majority of positions comprising the Commission is filled.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Advisory Neighborhood Commissions Quorum Definition Amendment Act of 1998".

Sec. 2. The Advisory Neighborhood Commissions Act of 1975, effective October 10, 1975 (D.C. Law 1-21; D.C. Code § 1-252 *et seq.*), is amended as follows:

- (a) Section 13(d) (D.C. Code § 1-261(d)) is amended by striking the second sentence.
- (b) Section 14(b) (D.C. Code § 1-262(b)) is amended by inserting at the end of the first sentence a new sentence to read as follows: "A Commission may declare a quorum and take official action if a majority of elected representatives of the Commission is present, provided that a majority of the single-member districts have representatives on the Commission pursuant to section 8."

Sec. 3. Fiscal impact statement.


The Council adopts the fiscal impact statement in the Committee report on Bill 12-263 as the fiscal impact statement required by section 602(c)(3) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 913; D.C. Code § 1-233 (c)(3)).

Sec. 4. This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), approval by the Financial Responsibility and Management Assistance Authority as provided in section 203(a) of the District of Columbia Financial Responsibility and Management Assistance Act of 1995, approved April 17, 1995 (109 Stat. 116; D.C. Code § 47-392.3(a)), a 30-day period of Congressional
