

D. C. Law 2-50

"District of Columbia Board of Elections
and Ethics Additional Compensation Act
of 1977"

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 2-153, on first and second readings October 25, 1977 and November 8, 1977, respectively. Following expiration of the ten-day period provided the Mayor, in which no action was taken, pursuant to Section 404(e) of the Act, this legislation was assigned Act No. 2-106, published in the December 16, 1977, edition of the D. C. Register and transmitted to both Houses of Congress for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional review period has expired and, therefore, cites the following legislation as D. C. Law 2-50, effective March 10, 1978.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

MARCH 10, 1978

To provide additional compensation for the Chairman of the District of Columbia Board of Elections and Ethics, and for other purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Board of Elections and Ethics Additional Compensation Act of 1977".

Sec. 2. Subsection (c) of section 4 of the Act entitled "An Act to regulate the election of delegates representing the District of Columbia to national political conventions, and for other purposes", approved August 12, 1955 (59 Stat. 599; D.C. Code, sec. 1-1104(c)) as amended, is amended to read as follows:

"(c)(1) Each member of the Board, excluding the Chairman, shall receive compensation at the rate of one hundred dollars (\$100) per day for each eight-hour (8-hour) period actually worked on the service of the Board, not to exceed the sum of twelve thousand and five hundred dollars (\$12,500) per annum.

"(2) The Chairman shall receive compensation at the rate of one hundred dollars (\$100) per day for each eight-hour (8-hour) period actually worked on the service of the Board, not to exceed the sum of twenty-six thousand and five hundred (\$26,500) per annum."

Sec. 3. This act shall become effective pursuant to section 602(c)(1) of the "District of Columbia Self-Government and Governmental Reorganization Act", approved December 24, 1973 (87 Stat. 814; D.C. Code, sec. 1-147(c)(1)): PROVIDED, HOWEVER, That the additional payment authorized by this act shall not be available until January 1, 1973.
