IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

DECEMBER 15, 1977

To provide for certain amendments to D.C. Law Nos. 1-110 and 1-124, to the District of Columbia Revenue Act of 1937, and to Title 32 of the District of Columbia Rules and Regulations.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,

That this act may be cited as the "Act to provide for

Amendments to D.C. Law Nos. 1-110 and 1-124".

- Sec. 2. Section 5(b) of the Motorized Bicycle Act, effective April 7, 1977 (D.C. Law 1-110) is amended by striking out "\$12.00." and inserting in lieu thereof "\$21.00.".
- Sec. 3. Section 101(c) of the Revenue Act for Fiscal Year 1978, effective April 19, 1977 (D.C. Law 1-124) is amended by striking out "G" and inserting in lieu thereof "H".
- Sec. 4. Section 104 of the Revenue Act for Fiscal Year 1978, effective April 19, 1977 (D.C. Law 1-124) is amended by striking out the entire section and inserting in lieu thereof the following new section:

"Sec. 104. The paragraphs entitled 'Class H' and 'Vehicles equipped with solid tires' in Part II of Appendix

A to Chapter III of Title 32 of the D.C. Rules and Regulations are hereby repealed."

Sec. 5. Subsection (b) of section 3 of the District of Columbia Revenue Act of 1937, approved August 17, 1937 is amended by adding immediately after the paragraph describing "Class F" the following new paragraph:

"Class G. For dealers' identification tags and dealers' transport identification tags, first set of tags, \$53, and \$19 for each additional set."

Sec. 6. Part II of Appendix A of Chapter III of Title

32 of the District of Columbia Rules and Regulations is

amended by adding immediately after the paragraph describing

"Class F" the following new paragraph:

"Class G. Dealers' identification tags and dealers' transport identification tags.

First set of tags......\$53.00

Each additional set.....\$19.00".

Sec. 7. This act shall take effect at the end of the period provided for Congressional review of acts of the Council of the District of Columbia in section 602(c) of the District of Columbia Self-Government and Governmental Reorganization Act.
