"Rental Housing Act of 1977 Extension Act of 1980".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 3-326, on first and second readings, July 15, 1980 and July 29, 1980, respectively. Following the signature of the Mayor on July 31, 1980, this legislation was assigned Act No. 3-231, published in the August 29, 1980, edition of the D.C. Register, (Vol. 27 page 3758) and transmitted to Congress on August 1, 1980 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and, therefore, cites this enactment as D.C. Law 3-106 effective September 26, 1980.

To extend the provisions of the Rental Housing Act of 1977. and to make certain technical amendments to the Rental Housing Conversion and Sale Act of 1980. and the Rental Housing Conversion Regulation Act of 1980.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA. That this act may be cited as the "Rental Housing Act of 1977 Extension Act of 1980".

Sec. 2. Section 906 of the Rental Housing Act of 1977, effective March 16, 1978 (D.C. Law 2-54; D.C. Code, sec. 45-1699.27) is amended by striking the phrase "September 30, 1980" and inserting the phrase "April 30, 1981" in lieu thereof.

Sec. 3. The Rental Housing Conversion and Sale Act of 1980. approved by the Mayor of the District of Columbia on July 2. 1980 (Act 3-204) is amended as follows:

(a) Section 405(a)(1) and (2) is amended by striking the phrase "408(c)+ 409(d)+ and 410(d)" and inserting the phrase "409(c)+ 410(d)+ and 411(d)" in lieu thereof; and

Sec. 4. Section 4 of the Rental Housing Conversion Regulation Act of 1980. approved by the Mayor of the District of Columbia on July 2. 1980 (Act 3-205) is amended by striking the figure "412" and inserting the figure "413" in lieu thereof.

Sec. 5. This act shall take effect after a thirty (30) day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-147(c)(1)).
