

D.C. Law 3-145

"District of Columbia Tissue Bank Act Amendment of 1980".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 3-312 on first and second readings, September 16, 1980 and September 30, 1980, respectively. Following the signature of the Mayor on October 14, 1980, this legislation was assigned Act No. 3-266, published in the October 24, 1980 edition of the D.C. Register, (Vol. 27 page 4663). This act was originally transmitted to Congress on October 17, 1980, and resubmitted on January 14, 1981 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 3-145, effective March 5, 1981.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

OCT 14 1980

To amend the District of Columbia Tissue Bank Act to authorize the Chief Medical Examiner to allow the removal of tissue from dead bodies in certain instances.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,

That this act may be cited as the "District of Columbia Tissue Bank Act Amendment of 1980".

Sec. 2. Section 9(b) of the District of Columbia Tissue Bank Act, approved September 10, 1952 (76 Stat. 536; D.C. Code, sec. 2-253(b)) is amended to read as follows:



"(b) The Chief Medical Examiner of the District of Columbia may allow tissue to be removed from any dead human body in his or her custody or under his or her jurisdiction:


PROVIDED, That the decedent had executed a gift of such tissue or that a person who is authorized to donate tissue from the body has authorized tissue

removal pursuant to the District of Columbia Anatomical Gift Act, approved May 26, 1970 (84 Stat. 265; D.C. Code, sec. 2-271 et seq.). Such tissue removal shall not interfere with other functions of the Chief Medical Examiner's Office."

Sec. 3. This act shall take effect after a thirty (30) day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 502(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (37 Stat. 313; D.C. Code, sec. 1-147(c)(1)).
