"Property Tax Relief Application Deadline Extension Act of 1979"

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 3-210, on first and second readings, January 22, 1980 and February 5, 1980 respectively. Following the signature of the Mayor on February 26, 1980, this legislation was assigned Act No. 3-156, published in the March 7, 1980, edition of the D.C. Register, (Vol. 27 page 987) and transmitted to Congress on March 3, 1980 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and, therefore, cites this enactment as D.C. Law 3-60 effective April 23, 1980.
