D.C. LAW 4-105

"Candy, Confectionary, Soft Drink, and Chewing Gum Sales Tax Amendment Act of 1981".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 4-231 on first and second readings, October 27, 1981 and February 23, 1982, respectively. Following the signature of the Mayor on March 10, 1982, this legislation was assigned Act No. 4-166, published in the April 2, 1982 edition of the D.C. Register, (Vol. 29 page 1405) and transmitted to Congress on March 15, 1982 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 4-105, effective April 30, 1982.

To repeal the eight percent (8%) sales tax on candy, confectionary, soft drinks, and chewing gum.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "Candy,
Confectionary, Soft Drink, and Chewing Gum Sales Tax
Amendment Act of 1981".

Sec. 2. Paragraph 5 of subsection (b) of section 114 of the District of Columbia Sales Tax Act, approved May 27, 1949 (63 Stat. 112; D.C. Code, sec. 47-2601(14)(b)(5)) is amended by deleting the phrase "and except for sales of candy, confectionary, chewing gum, and soft drinks which are taxable wherever sold.".

Sec. 3. (a) Except as provided in subsection (b) this act shall take effect after a thirty (30)-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87)

Stat. 813; D.C. Code, sec. 1-233(c)(1)).

(b) The provisions of section 2 shall take effect on the first day of the first month which begins more than thirty (30) days after the date this act becomes effective.
