
NOTICE

D.C. LAW 4-107

"Veterans' Appointment Preference Extension Act
of 1982".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 4-294 on first, amended first, second amended first readings and second readings, January 26, 1982, February 9, 1982, February 23, 1982 and March 9, 1982, respectively. Following the Signature of the Mayor on March 26, 1982, this legislation was assigned Act No. 4-168, published in the April 2, 1982 edition of the D.C. Register, (Vol. 29 page 1410) and transmitted to Congress on April 1, 1982 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 4-107, effective May 19, 1982.

D.C. ACT 4 - 168

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

MAR 26 1982

To extend the appointment preference for veterans.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "Veterans'
Appointment Preference Extension Act of 1981".

Sec. 2. Section 703(e) of the District of
Columbia Government Comprehensive Merit Personnel Act
of 1978, effective March 3, 1979 (D.C. Law 2-139; D.C.
Code, sec. 1-607.3(e)) is amended to read as follows:

"Except for the appointment preferences provided
in subsections (h), (i), (j), and (k) of this section,
no person shall receive any appointment preference
after five (5) years from the date of separation from
the Armed Forces of the United States."

Sec. 3. Section 703 of the District of Columbia
Government Comprehensive Merit Personnel Act of 1978,
effective March 3, 1979 (D.C. Law 2-139; D.C. Code,
sec. 1-607.3) is amended by adding new subsections
"(h)", "(i)", "(j)", and "(k)" at the end thereof to
read follows:

"(h) The unmarried widow or widower of a veteran

shall be accorded the same preference in appointment as would be accorded to her or him in the Federal service pursuant to 5 U.S.C. secs. 2108(3)(D) and 3309(1).


"(i) The wife or husband of a service-connected disabled veteran shall be accorded the same preference in appointment as would be accorded to her or him in the Federal service pursuant to 5 U.S.C. secs. 2108(3)(E) and 3309(1).

"(j) A person classified as thirty percent (30%) or more disabled under subsection (b) of this section shall receive an appointment preference as provided in that subsection.


"(k) A person who served during the Vietnam conflict, who has a discharge of other than dishonorable, shall receive an appointment preference for a period not to exceed ten (10) years from the effective date of the Veterans' Appointment Preference Extension Act of 1981."

Sec. 4. This act shall take effect after a thirty (30)-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved

December 24, 1973 (87 Stat. 813; D.C. Code, sec.
1-233(c)(1)).
